## Section 5 - Fire Fighting Measures

<b>Fire and Explosion Hazards</b>	Batteries may burst and release hazardous decomposition products when exposed to a fire situation.

Increase ventilation. Carefully collect batteries and place in an appropriate container for disposal. Remove spilled liquid with absorbent and contain for disposal.

- the package contains lithium ion cells or batteries;
- the package must be handled with care, and that a flammability hazard exists if the package is damaged;
- special procedures should be followed in the event the package is damaged, to include inspection and repacking if necessary; and
- a telephone number for additional information.

Each package must be labelled with a lithium battery handling label;

Any person preparing or offering cells or batteries for transport must receive adequate instruction on these requirements commensurate with their responsibilities.

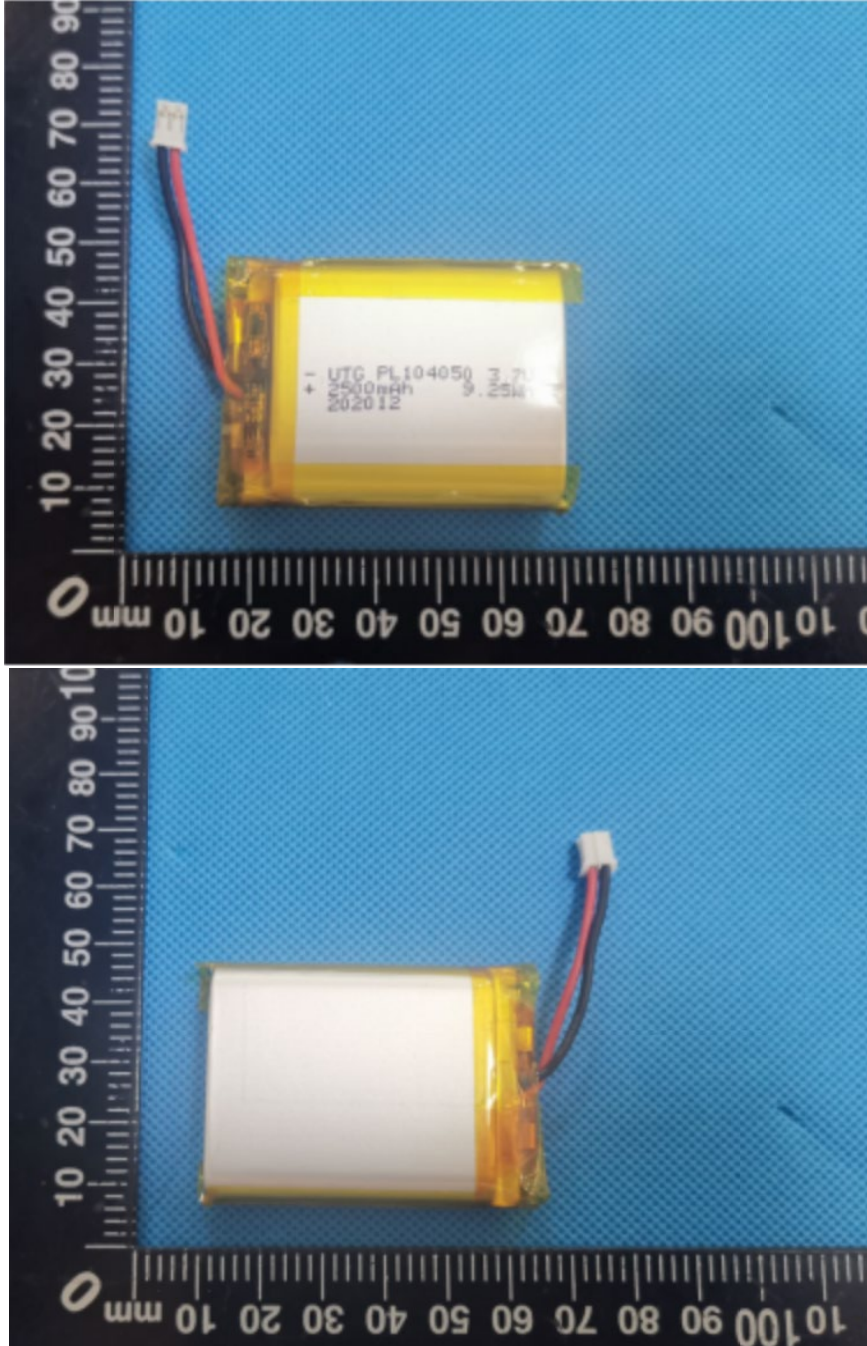
